

within 30 days, Record Establishing Council of WorldKings will check, research, review and confirm your document. If your record meets the standards in accordance with the regulations of WorldKings, we will send World Record Certificate to you. Besides, your record will be made public through WorldKings Communications.

**□ The direct record certification.** This method is primarily for the records which are performed or like a event. After reviewing your world record registration document, we will contribute our idea to develop your record into a world record in accordance with the available standards and the regulations of WorldKings. When your record is performed, our Record Establishing Council will come to confer World Record Certificate and campaign medal on you directly. If the place of the event is outside the city where WorldKings Office locates, you have to pay for living expenses, travel expenses (airfare, accommodation costs) for the representative of Record Establishing Council of WorldKings.
